At the last general meeting of the Hiltonia Civic Association, a motion to support proposed Bike Path was voted upon. The Association voted to support the Bike Path, provided that adequate security would be guaranteed to those residential areas directly bordering the path.

Listed below are paraphrased city ordinances that if obeyed would make Hiltonia just a bit better than it already is.

## Air Pollution

- No open burning is allowed in a residential neighborhood i.e., (lawn debris or leaves)

#### Dogs

- No pet owner shall permit their pet to make a nuisance on a sidewalk or any public place (your neighbors yard)
- All dogs must be leashed when not confined to their owners property (no loose dogs allowed). Dogs must be leashed while out being walked.
- Barking dogs are a disruption of the peace. It is unlawful to allow your animal to disrupt your adjacent neighbors. (keep your dogs quiet)
- Any dog over six (6) months must be licensed. Dog vaccinations are required before the dog is licensed.

## Garbage

- Garbage must be placed in leakproof containers of metal or plastic,
- Full containers cannot weigh more than (50) fifty pounds.
- BRANCHES must be tied in bundles not longer than four (4) ft. in length or heavier than (50) fifty pounds.
- Furniture, stoves, refrigerators, or other large items will be picked up by calling Sanitation Department for special pick-up.
- Rubbish from construction must be removed by owner as soon as possible after completion.
- Your yard, sidewalk or gutter must be clean of all debris. The proper storage and handling of litter is your responsibility.

## Property

- Every occupant shall keep his property in a clean and sanitary condition.
- Steps, walks, driveways shall be maintained so as to afford safe passage under normal use and weather.
- All snow and ice are to be removed within 12 daylight hours from the last snow fall.

# Property (continued)

- No person shall sweep litter in the gutter. Sidewalke and curbs shall be free of litter and weeds.
- Lawns are to be cut as to present a neat appearance. Grass is not to exceed 5 in. in length.
- Home owners are responsible to construct, maintain and repair the sidewalks, curbs and gutters abutting their property.
- \*\* Failure to comply with the above could end with the city making the repairs and billing the homeowner.
