COVERED DISH DINNER DELIGHTS

March 1981

Claremont Diner-Restaurant "THAT SALAD"

1 medium head cabbage shredded	4 tbl. sugar
2 thin carrots sliced	3 tbl. water
1 onion - sliced or shredded	10 tbl vinegar
1 green pepper-sliced or shredded	4 tbl. salad oil
	2 tsp. salt
	2 cucumbers sliced
	pepper to taste

HOW TO PREPARE

Simply put all of the above in a large salad or mixing bowl and toss. Marinate all night or for several hours in the refrigerator. This salad is always better if made the day before and allowed to marinate. One other way to look at it is thisalways make more than enough. "THAT SALAD" can be used as a main course, with sandwiches or as an accompaniment to roast pork or baked ham.

PUBLICITY COMMITTEE

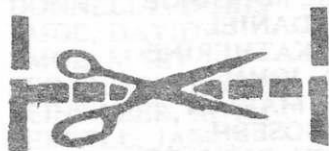
PETER ALUOTTO -- NEIGHBOR AT WORK

In the February 1, 1981 issue of the Hilltone, **Peter Aluotto** of Stuyvesant wrote an article in the Hilltone entitled, "Community Development Block Grant -- a program." In this article Peter describes the birth of his idea to use Community Block Development Grant money in the West ward for the rehabilitation and resale of now vacant and abandoned buildings, the purpose of which is to attract stable moderate income families to the West Ward and return these buildings to the tax rolls.

Peter's idea was presented to the Hiltonia Association at a General Membership Meeting at which time the members voted to approve his plan. The idea was then presented to several other West Ward Associations where Colonial Avenue was selected as the target area and finally, to gain broad base support, to the TCCA (Trenton Council of Civic Associations). On January 7, 1981, the proposal was presented to City Council under the aegis of the TCCA who agreed to act as the project sponsor. The concept was melded into another project that the City had been working on - Housing Development Corporation.

Peter kept working on this concept and West End Avenue was selected as the target area. At long last and only two years after its conception, Housing Incorporated was born when the corporation was awarded \$109,000, not quite as much as Peter had hoped for but a good start. The target area was moved to Colonial Avenue (Peter's original choice) and 10 houses were selected for rehabilitation, 7 of which are owned by the City and 3 of which the City will acquire from the Veterans Administration. These 10 houses will be rehabilitated and sold in the not too distant future. **Stu Anderson** of Kensington, as president of the TCCA, will sit on the board of Housing, Incorporated.

Editor's Note: The Hiltonia Association is proud of the work Peter has done in seeing that Housing, Incorporated became a reality. We all wish the corporation much success.

A Request from CITY HALL

Mr. Capone, of the City Department of Public Works, has asked that we pass along a request to Hiltonia residents. City ordinances require that tree branches and logs be cut to a maximum of 4 feet and placed at curbside on the morning of scheduled garbage collection days. They should not be placed in the road along with leaves raked from your yard, as this creates a hazard. Unless logs and branches are properly prepared for collection, they will not be picked up. In the past, Mr. Capone has sent a truck and front end loader for such debris, but he will not be able to provide this special service in the future.

HILTONIA PLAN UPDATE

The committee formed to update and revise the *Hiltonia Plan* has nearly completed its work and will present the revised plan to the general membership at the March Meeting.

The committee has asked the City to replace approximately 35 trees as requested by homeowners who returned questionnaires by early December. Approximately 15 forms have been returned since then and a supplementary list has been submitted to the City asking that those homeowners be given trees as well. If you have not returned a form and want the City to plant a tree between the curb and sidewalk near your property, please contact **Ellen Wry** (121 Buckingham) or one of the committee members: **Larry Carter**, **Joan Anderson**, **Myrna Kushner**, **Greg Smith**, **Ken Kyte**, **Harvey Stern** and **Norma Stern**. Trees will be planted after a City survey is completed in early Spring.

The committee also asked the City to do some road repairs in the neighborhood. The City Department of Public Works (Mr. Tuccillo) reports that much of the work was done early December and that the remaining work will be done in the Spring.

The new plan contains two areas which involve all of us: maintenance and use of Cadwalader Park and the problem of badly deteriorated properties in the neighborhood. The latter is a rare occurrence, but where it exists, it has caused sufficient concern that several homeowners have asked the Association for help. Please watch for notice of the March meeting date so that we can hear from you on this and have your suggestions on other aspects of the plan as well.

The committee and your officers need to know your views so that the Association can continue to make your neighborhood a place to be proud of. We hope to hear from you and to see you at the March meeting.
